The States for Passenger Rail Coalition, Inc. (SPRC) is an advocacy group comprised of State departments of transportation and passenger rail authority leaders from across the nation who work together to support the development and growth of passenger rail service throughout the United States.

Established in January 2000, the SPRC currently has members representing the States of California, Connecticut, Illinois, Indiana, Iowa, Louisiana, Maine, Massachusetts, Michigan, Minnesota, Missouri, New York, Nevada, North Carolina, Oklahoma, Oregon, Pennsylvania, Vermont, Virginia, Washington, and Wisconsin. Additional members include the Capitol Corridor Joint Powers Authority, the Los Angeles-San Diego-San Luis Obispo Rail Corridor Agency, the San Joaquin Joint Powers Authority, and the Northern New England Passenger Rail Authority.

Our 25 members sponsor a combined 30 intercity passenger rail (ICPR) routes serving 296 communities across America, with two States also connecting to Canada. Last year our trains carried almost 15 million passengers, representing 48% of Amtrak's total ridership. Safety is paramount to our services and we are committed to ensuring it for all passengers, employees, host railroads, and the communities we serve. National safety statistics show that passengers and rail employees are safer on intercity trains than any other mode of transportation.
